Debit orders are arranged by the school. Should you prefer to use a stop order, you must personally arrange this with your bank. (PAYMENTS OF SCHOOL FEES BY DEBIT ORDER IS PREFERABLE AND WILL BE CHEAPER FOR YOU.)

NOTES:

- A Resolution of the General Parent's Meeting of 3 November 2022 determines that a minimum voluntary school fee of R9 240.00 must be paid for 2023 (negotiable for cases with merit). This implies that parents who qualify for full subsidy will have to pay at least R9 240.00 per learner, (payable in 11 equal instalments of R840.00 each).
- 2. As soon as an account is **two months** in arrears, **the account for the full outstanding fee for the year** shall be handed over for recovery.
- 3. A Resolution of 3 November 2022 determines that tours, clinics, overnight excursions and the Matric Farewell do not form part of the school programme. (These are privileges). If school fees are in arrears, the aforementioned privileges will be evoked and the school fees will be settled first.
- 4. The cost of the Gr 10-12 practical subjects (CAT, EGD and Consumer Studies) is R125.00 per subject per term. This cost is apart from the established school fees or minimum school fees.
- 5. Subsidy for school funds is available for parents who qualify **and who have applied accordingly**. Until the subsidy has been approved, the full monthly school fee must be paid.
- 6. The Governing Body has the right to hand over the accounts which are in arrears to a third party. The parent(s) / guardian(s) will be held accountable for all the legal fees as well as additional costs of the lawyer/collector. The Governing Body reserves the right to have a parent/guardian blacklisted for not/poor paying of debts.
